# Faculty Footnotes

## Adjoa Aiyetoro

March 1, Associate Professor **Adjoa Aiyetoro** was the speaker at Washington University in St. Louis School of Law Access to Justice Project's Twelfth Annual Public Interest Law and Policy Speakers Series. Her topic was "Why Reparations For Black People of African Descent are Important to Democracy." She has been asked to publish her paper in the fall issue of the *Washington University Journal of Law and Policy*.

March 22 and 23, Aiyetoro was a member of a delegation of six UALR faculty and staff members, led by Chancellor Joel Anderson, to The Winter Institute of Racial Reconciliation housed at University of Mississippi, in Oxford, Miss. The Racial Attitudes Committee is considering developing a Research Institute on Race and Equality and visited The Winter Institute to discuss its mission, organization, and program.

The National Conference of Law Reviews invited Professor **Coleen Barger** and University of Texas Professor Wayne Schiess to speak to editors about the benefits of using the *ALWD Citation Manual* for their reviews and journals. Barger and Schiess made their presentation on March 20 at Texas Wesleyan University School of Law in Fort Worth, Texas, the school that hosted this year's conference.

Arkansas Bar Foundation Professor **Lynn Foster** served as a member of an American Bar Association inspection team in March. The team visited Creighton University School of Law. Foster also served as the Association of American Law Schools reporter for the inspection.

## Ken Gallant

Gallant** just completed three one-year terms as chair of the Water Supply Committee of Beaverfork Volunteer Fire Department, Inc., a non-profit corporation that is Arkansas' only combination VFD and local water supplier. Gallant is also a member of the Arkansas ADR Commission; the organization sponsored the summit.
