

**UNIVERSITY OF ARKANSAS AT LITTLE ROCK**

**TRANSMITTAL OF FACULTY SENATE LEGISLATION**

(Faculty Senate legislation is to be submitted to the chancellor to approve or disapprove within *ten calendar days* of the Faculty Senate action. The chancellor may approve or veto any Faculty Senate legislation within a period from the *eleventh through the twenty-fifth calendar day* after such action has been presented, unless the Assembly has been petitioned to amend or rescind the Faculty Senate legislation. In the latter case, the chancellor's approval or veto shall be made no later than fifteen calendar days after the Assembly has voted on and failed to approve a motion to amend or rescind a legislative action of the Faculty Senate. The chancellor shall provide written reasons for a veto to the Faculty Senate.)

**To the Chancellor of the University of Arkansas at Little Rock:**

The following resolution/legislation passed the UALR Faculty Senate on March 13, 2015.

Motion FS\_2015\_9. Faculty Senate *Executive Committee* (Legislation. Majority Vote at One Meeting) Faculty Excellence Awards Revisions (no second required)

Whereas Faculty Excellence Awards policy cites the specific colleges that predate restructuring and such citation will have to be modified whenever a change in college or college names should occur,

Therefore Be it Resolved that the custodian of Policy 403.8 shall be the Faculty Senate, and

Be it Further Resolved that the source be changed to Faculty Senate Minutes (3/13/2015), and

Be it Further Resolved that the revision history be 9/21/2007; 3/13/2015, and

Be it Further Resolved that the paragraphs be added at the end of the Policy,

*Citation and Modification*

*This policy must be cited in curricular documents that excerpt it (such as the Undergraduate Catalog) and the Faculty Senate Executive Committee (or their designee) should review those documents before they are finalized. Wherever there is a substantive conflict between the document which quotes this policy and this policy, this policy shall be followed.*

*The policy can be modified through legislative action of the Faculty Senate (see Article III of the Constitution of the Assembly of the University of Arkansas at Little Rock).*

And Be it Further Resolved that the paragraph be changed,

~~In the event of administrative reorganization, the list of colleges and schools shall be adjusted accordingly.~~

The term "college/schools" refers to each college or school that has representation in the UALR Faculty Senate.
