- Key questions: Who PLA Coordinator? [A: Testing Services has indicated interest, but as yet undetermined.
- Use PLA Coordinator consistently in legislation.
- Q: Identify committee(s) to evaluate portfolio evaluations for PLA

B. Motion_FS_2020_21 Core Council (Legislation. Majority vote at one meeting; no second required) Eliminate distinction between college and standard core. Sen. Blevins-Knabe presents.

- Eliminate distinction between College and Common Core
- Make catalogue more understandable
- Remove all references to College Core; replace with UA Little Rock Core Curriculum
- Use Flex to indicate menu of courses that are optional but satisfy same core requirement

COMMENT (Sen. Wright): The last and current reorganizations of the colleges places the University in a situation where such changes ("administrative reshuffling of departments") creates a de facto curriculum change, thereby violating the UA Little Rock Constitution. "We should make sure that we never do something like this again." (01:49:35 – 01:50:35)

• Friendly Amendment: UA Little Rock Core Curriculum consists of 6 hours of Communication - Written, 3 hours of Fine Arts, 3 hours of Flex, 3 hours of History of Civilization, 3 hours of Humanities, 3 hours of Mathematics, 8 hours of Science, 3 hours of Social Sciences, and 3 hours of U. S. Traditions.



• Friendly Amendment: Students in the School of Business are required to take Math 1302 or any other math for which Math 1302 is a prerequisite.
