7293 Field Experience III: Expand the application skills developed in assessment intervention design, and program evaluation of students with disabilities. . . . . Focus will be on programs for students in secondary schools. Emphasis will be placed on providing access to the general education in grades 4-12 for students with disabilities. Co-requisite SPED 7353.

7302 Technology in Special Education: Course will prepare teachers to be better able to respond to individuals' functional needs in order to enhance their access to the general or special education curricula.....

7344 Collaborative Partnerships in Education: Designed to promote development and effective use of advanced skills in the areas of consultation and collaboration............................ Prerequisite: SPED 7301, 7305
