PART 1. - GENERAL

1.01 DESCRIPTION OF REQUIREMENTS


- A. Definition: An alternate is an amount proposed by Bidders and stated on Bid Form that will be added to or deducted from the Base Bid amount if Owner decides to accept a corresponding change in either scope of work or in products, materials, equipment, systems or installation methods described in Contract Documents.
- B. Coordination: Coordinate related work and modify and adjust adjacent work as required to ensure that work affected by each accepted alternate is complete and fully integrated into project.
- C. Notification: Immediately following award of Contract, prepare and distribute to each party involved, notification of status of each alternate. Indicate whether alternates have been accepted, rejected or deferred for consideration at a later date. Include a complete description of negotiated modifications to alternates, if any.
- D. Schedule:
 - 1. Include as part of each alternate, miscellaneous devices, appurtenances and similar items incidental to or required for complete installation whether or not mentioned as part of alternate.

1.02 SCHEDULE OF ALTERNATES:

A. ALTERNATE NO. 1:

REPLACE the concrete parking lot with asphalt.

Replace the concrete parking lot with an asphalt system, installed per the detail indicated here. See Sheet C100:





State on your Bid Form the amount to DEDUCT from the Base Bid if this alternate is accepted.

B. ALTERNATE NO. 2:

DELETE the New Concrete Sidewalk on Little Pine St. only. See sheets C100 and C101..

Delete the portion of sidewalk on Little Pine Street only, including all associated tree removal, excavation, stabilization, grading, etc. The sidewalk on Pine Street shall remain in the project.

State on your Bid Form the amount to DEDUCT from the Base Bid if this alternate is accepted.
